**Eligibility: Fine art & fine crafts in all media.**

Only artists or craftspeople selling their own works will be eligible to participate. No dealers, agents or representatives will be permitted. All work must be original and creative. Not acceptable are kits, commercial molds, or commercially fabricated forms. Booth sharing is acceptable; all artists must be listed on the application.

The committee reserves the right to view each booth after setup and requests that any work not up to our standards be removed. The artists must come with their craft and have enough merchandise for all days. Demonstrations of art & craft are welcomed.

**Application Directions:**

Please complete attached application and return with a CD of three (3) images of work and one (1) of display no later than March 20, 2010. Artists who previously participated in Arts in Harmony need not send a CD. No late entries will be accepted. Please include name of artist on CD. **Notifications of acceptance will be sent by April 1, 2010.**

**Booth Fee:** \$65 payable upon acceptance, refundable up to April 15, 2010. Additional booth space can be purchased for \$65 each.

Tent rental is additional; call Erika at (812)682-3156 for rental information. Spaces are large enough to fit a 10x10 tent and usually provide plenty of space to exhibit work in front as well.

**Security:**

General security is provided from 5:00 p.m. Friday until 4:00 p.m. Sunday night.

**Music:**

Music will be provided by the New Harmony Artists Guild throughout the weekend. Performance schedule will be published closer to event date.

**Weather:**

Fair will be held rain or shine. Artists are responsible for providing their own tents or may rent one through the fair.

**Bank:**

Artists should bring sufficient change for the weekend. There are no banks open in New Harmony on Saturday or Sunday.
